Family Educational Rights and Privacy Act (FERPA) **Model Notice for Directory Information**

The Family Educational Rights and Privacy Act (FERPA), a Federal law, requires that the Franklin City School District with certain exceptions, obtain your written consent prior to the disclosure of personally identifiable information from your child's education records. However, Franklin City Schools may disclose appropriately designated "directory information" without written consent, unless you have advised the District to the contrary in accordance with District procedures. The primary purpose of directory information is to allow the Franklin City School district to include this type of information from your child's education records as appropriate in certain school publications. A few examples include:

- School newspaper articles highlighting school activities;
- A playbill, showing your student's role in a drama production;
- The annual yearbook;
- Honor roll or other recognition lists;
- Graduation programs;
- Sports activity sheets such as for wrestling, showing weight and height of team members;
- District developed web page and
- School videos shown on public access television
- Social Media

Directory information, which is information that is generally not considered harmful or an invasion of privacy if released, can also be disclosed to outside organizations without a parent's prior written consent. Outside organizations include, but are not limited to, companies that manufacture class rings or publish yearbooks. In addition, two federal laws require local education agencies (LEAs) receiving assistance under the Elementary and Secondary Education Act of 1965 ESEA) to provide military recruiters, upon request, with three director information categories - name, addresses and telephone listings - unless parents have advised the LEA that they do not want their student's information disclosed without their prior written consent.1

If you do not want the Franklin City School District to disclose directory information from your child's education records without your prior written consent, you must notify the District by signing and returning the bottom portion of this form to your child's school. Franklin City Schools has designated the following information as directory information: (Note: According to law a school district may, but does not have to, include all the information listed below.)

- Student's Name
- Address
- Telephone listing
- Photograph
- Date and place of Birth
- Major field of study

- Dates of attendance
- Grade level
- Weight and height of members of athletic teams
- Degrees, honors and awards received
- The most recent educational agency or institution attended
